Introduction

Robin-Banks Entertainment, LLC (the **"Company" or "We")** respects your privacy and is committed to protecting it through our compliance with this Privacy Policy (the **"Policy"**).

This Policy describes the types of information We may collect from you or that you may provide when visit the website https://www.robin-banksentertainment.com/ (the "Website") and our practices for collecting, using maintaining, protecting, and disclosing that information.

This Policy applies to information We collect:

- On this Website:
- In email, text, and other electronic messages between you and this Website; and
- When you interact with our advertising and application on third-party websites and services, if those applications or advertising include links to this Policy.

It does not apply to information collected by:

- Us offline or through any other means, including on any other website operated by the Company or any third-party (including our affiliates and subsidiaries, as applicable); or
- Any third-party (including our affiliates and subsidiaries), including through any application or content (including advertising) that may link to or be accessible from (or on) the Website.

Our other websites, if applicable, and these third-parties may have their own privacy policies, which We encourage you to read before providing information on or through them.

Please read this Policy carefully to understand our policies and practices regarding your information and how We will treat it. If you do not agree with our policies and practices, you have the option to not utilize the Website. By accessing or using the Website, you agree to the terms of this Policy. This Policy may change from time to time (see <u>Changes to our Privacy Policy</u>). Your continued use of the Website after We make changes is deemed to be acceptance of those changes, so please check the Policy periodically for updates.

Children Under the Age of 13

Our Website is not intended for children under 13 years of age. If you are under 13, you may use this Website only with the involvement of a parent or guardian. No one under age 13 may provide any personal information to or on the Website. We do not knowingly collect personal information from children under 13. Information We Collect About you and How We Collect It

We collect several types of information from and about users of the Website, including information:

By which you may be personally identified, such as name, postal address, telephone, or e-mail address ("Personal

- About your internet connection, the equipment you use to access our Website, and usage details.

We collect this information:

- Directly from you when you provide it to us;
- Automatically as you navigate through the Website. Information collected automatically may include usage details, IP addresses, and information collected through cookies, web beacons, and other tracking technologies; and
- When applicable, from third-parties.

Information you Provide to Us.

The information We collect on or through the Website may include:

- Information that you provide by filling in forms on the Website, including information provided at the time of registering to use the Website, posting material, or requesting further services. We may also ask you for information when you report a problem with the Website;
- Records and copies of your correspondence (including email addresses), if you contact us;
- Your responses to surveys that We might ask you to complete for research purposes;
- Details of transactions you carry out through the Website and fulfillment of your orders. you may be required to provide financial information before placing an order through the Website; and
- Your search queries on the Website.

You may also provide information to be published or displayed (hereinafter "**posted**") on public areas of the Website or transmitted to other users of the Website or third-parties (collectively, "**User Contributions**"). Your User Contributions are posted on and transmitted to others at your own risk. Please be aware that no security measures are perfect or impenetrable. Additionally, We cannot control the actions of other users of the Website with whom you may choose to share your User Contributions. Therefore, We cannot and do not guarantee that your User Contributions will not be viewed by unauthorized persons.

<u>Information We Collect Through Automatic Data Collection Technologies.</u>

As you navigate through and interact with the Website, We may use automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns, including:

- **Usage Details.** Details of your visits to the Website, including traffic data, location data, logs, and other communication data and the resources that you access and use on the Website; and
- **Device Information.** Information about your computer, internet connection, and mobile device, including your IP address, operating system, phone model, mobile network, device's telephone number, and browser type.

The information We collect automatically is statistical data and does not include Personal Information, but We may maintain it or associate it with Personal Information We collect in other ways or receive from third-parties. It helps us to improve the Website and to deliver better and more personalized services, including by enabling us to:

- Estimate our audience size and usage patterns;
- Store information about your preferences, allowing us to customize the Website according to your individual interests:
- Speed up your searches; and
- Recognize you when you return to the Website.

The technologies We use for this automatic data collection may include:

Cookies (or browser cookies). A cookie is a small file placed on the hard drive of your computer. you may refuse to

accept browser cookies by activating the appropriate setting on your browser. However, if you select this setting, you may be unable to access certain parts of the Website. Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies when you direct your browser to the Website.

- **Flash Cookies.** Certain features of the Website may use locally stored objects (or Flash cookies) to collect and store information about your preferences and navigation to, from, and on the Website. Flash cookies are not managed by the same browser settings as are used for browser cookies. - Web Beacons. We do not collect Personal Information automatically, but We may tie this information to Personal Information about you that We collect from other sources or that you provide to us. How We Use your Information

We use information that We collect about you or that you provide to us, including any Personal Information, to:

- Respond to comments, questions, and provide customer service;

Even though We do not disclose your Personal Information for these purposes without your consent, if you click on or otherwise interact with an advertisement, the advertiser may assume that you meet its target criteria.

Disclosure of your Information

We may disclose aggregated information about our users, and information that does not identify any individual, without restriction.

We may disclose Personal Information that We collect or you provide as described in this Policy:

- To our subsidiaries and affiliates;
- To contractors, service providers, and other third-parties We use to support our business and who are bound by contractual obligations to keep Personal Information confidential and use it only for the purposes for which We disclose it to them;
- To a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of the Company's assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which Personal Information held by the Company about the Website's users is among the assets transferred;
- To third-parties to market their products or services to you. We contractually require these third parties to keep Personal Information confidential and use it only for the purposes for which We disclose it to them;
- To fulfill the purpose for which you provide the Personal Information;
- For any other purpose disclosed by us when you provide the information; and
- With your consent.

We may also disclose your Personal Information:

- To comply with any court order, law, or legal process, including to respond to any government or regulatory request;
- To enforce or apply our Terms of Use and other agreements, including for billing and collection purposes; and
- If We believe disclosure is necessary or appropriate to protect the rights, property, or safety of the Company, our customers, or others, including exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction.

Choices About How We Use and Disclose your Information

We strive to provide you with choices regarding the Personal Information you provide to us. We have created mechanisms to provide you with the following control over your information:
